- * All samples shipped open account to qualified/credit approved dealers.
- * Be able to return unsold samples, if desired, within 60 days without incurring a restocking fee.
- * No sampling between November 1 and January 15.

How To Return Samples

IMPORTANT: To receive full credit on sample product, dealers must keep product for 30 days and return at own expense before 60 days (from invoice date).

Samples received before 30 days or after 60 days will be assessed a 10% handling/re-stocking fee.

- 1. Sample returns do not require prior written authorization.
- 2. Simply fill out an E-form, part no. 99521-80.
- 3. Note Reason Code of "F" (other) and write "sample" on the line provided (see attached sample).
- 4. Sign the E-form and retain the golden rod copy for your files.



5. Enclose the E-form with the return sample product and ship to H-D using the respective return label.

Use label F-1485, which is a two-tone green label, when returning accessory items with a ∇ and/or Z suffix.

Use label F-1462, which is a two-tone brown label, when returning all other parts and accessories.

Additional return labels may be ordered through the Parts & Accessories Department or thru our Stationery Department.

- 6. Your P & A account will be credited at full dealer net in effect at the time of return provided the return falls within the 30-60 day time frame.
- All sample returns should be in original packaging.
- Broken package quantities and obsolete items will not be accepted for return.
- All refused samples returned to H-D will receive an automatic 20% handling/re-stocking fee.
